- 2. Booth spaces are first come, first served. No transfers
- 3. Applications must be received by the Arts and Crafts Committee by August 15, 2025.
- 4. Arts & Crafts Committee reserves the right to refuse any application. No live animals, no guns, knives, etc.
- 5. If your application is declined; money, check, or money order will be returned. No refund can be made on cancellation. Checks or money orders can be made payable to Pontotoc County Bodock Festival. When submitting your application you are accepted if for some reason you are denied then you will be contacted.
- 6. Booth fee of \$100.00 for the festival at the Pontotoc Gateway Pavilion. Applications received after August 15, 2025 will be \$125.00
- 7. No commission is charged, but State Sales Tax will be collected at Hospitality Booth at 4:00 pm Saturday.
- 8. Vendor is responsible for his or her own display and tent.
- 9. Vendor's vehicles will be allowed in parking lot to unload only from 6:00am to 7:30am on Saturday. Parking area is provided for vendors. Vendors will be allowed in the parking lot to load up their vehicles from 4:00pm to 5:00pm on Saturday. All booths will be gone at 5:00pm. This is Mandatory. Please do not argue this point on the day of the festival. Please do not bring vehicle on the parking lot before 4:00pm.
- 10. Vendors responsible for trash pickup at their booth. Booth should remain up for the entirety of the scheduled time for Saturday.
- 11. No pets on allowed.
